Description

Klercide 70/30 IPA is a blend of 70% v/v Isopropyl Alcohol with deionised water. Klercide 70/30 Denatured Ethanol is 70% v/v denatured ethanol blended with deionised water.

The alcohol blend is 0.2 micron filtered, filled and double bagged in a Grade C (ISO class 7) cleanroom, before irradiation using a validated process at no less than 25 kGy to ensure a spore free alcohol.

All trigger spray bottles incorporate the patented SteriShield Delivery System and an adjustable trigger spray. The unique way in which the SteriShield Delivery System works as a closed system, ensures that the sterility of the contents is preserved throughout use.

Protocol

Ready to use, so can be sprayed directly onto the surface to be sanitised. Always ensure the whole surface is in contact with the liquid. For optimum results, wipe the surface to physically remove any contaminants.

Use biocides safely. Always read the label and product information before use.

Validation

Manufactured by a BS EN ISO 9001:2008, BS EN ISO 13485:2012 and European Medical Device Directive 93/42/EEC accredited company.
