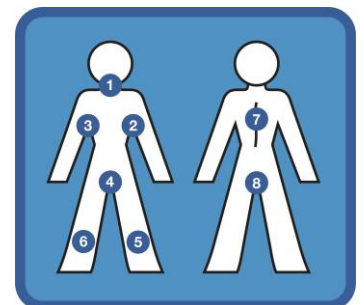
Avoid contact with eyes. Apply on uninfected and healthy skin. Only for external use. Rinsing optional

Use one glove for each part of the body :

- 1- Face, neck, chest
- 2- Left arm and armpit
- 3- Right arm and armpit
- 4- Perineum

- 5- Left leg
- 6- Right leg
- 7- Upper back
- 8- Lower back

Do not dispose of the glove in the toilet.

INGREDIENTS

LOCAL TOLERANCE (IRRITATION, ALLERGY, TOXICITY)

Analysis of the results obtained in experimental conditions shows the absence of irritant potential to the skin and eyes and good overall gynecological tolerance in normal conditions of use. Tests carried out:

- Evaluation of the ocular irritant potential by application on the chorio-allantoid membrane of the hen's egg (HET-CAM)
- Assessment of cutaneous compatibility after single application (48 hour semi-occlusive patch-test)
- Evaluation of the gynecological tolerance and the acceptance of a cosmetic product after 21 days of use.

The perfume used in our product complies with the latest IFRA recommendations for the stated application and dosage. Analysis of the results obtained in experimental conditions shows that the finished cosmetic product (lotion) can be considered as hypoallergenic. The clinical study of skin sensitizing potential confirmed the absence of an allergic reaction with the test product.

The risk of systemic toxicity can be ruled out taking into account the available data for all the substances in the formula and for the intended application in normal conditions.

STORAGE CONDITIONS

Normal conditions of conservation & storage: not to be exposed to moisture and sun, must be stored at a temperature between 15°C and 25°C.

Shelf life: 24 months
