Quality Systems: Manufactured in a facility holding ISO 9001:2000 and 89/686/EEC Article 11b certifications.

Sampling & Inspection: In accordance with ISO 2859.

Shelf Life: Five (5) years from date of manufacture.

Bar Codes: Each size carries a unique bar code on the carton (ITF-14).

This allows automatic data entry into Stock Control Systems.

Lot Number: This is shown on the sealed pouch and outer carton to provide product traceability.

Packaging: One cuffed pair per inner plastic wallet;

One inner wallet per 'Easy Tear' PE bag; 10 pairs per sealed outer PE bag; 20 outer bags per carton liner; One carton liner per carton (200 pairs).

Compatibility: ISO Class 4 & EU GMP Grade A.
